**PROOF OF INSURANCE ORC 4609.101**

Every person who receives a traffic citation in the State of Ohio is required to produce proof of insurance at one of the following times by showing a valid insurance card from the time of the offense in either your name or for the vehicle.

1. To the officer at the time of violation.
2. At your court appearance
3. At the time you pay your traffic citation by providing a copy of your insurance card.
4. If you pay by internet, you will be notified by the BMV and must provide your **proof** to them within the time indicated.

**IF YOU FAIL TO PROVIDE THE REQUIRED PROOF:** You will be reported to the BMV and a notice of License **SUSPENSION** will be sent to you from the Bureau of Motor Vehicles (BMV).
