1. Kalahari Tickets:

Director Kovick reported in 2017, Kalahari allowed Portage County to purchase tickets at a reduced rate of \$30.00 per ticket if the County sold a minimum of 100 tickets (regular ticket prices range from \$59-85 per ticket). Last year, the County sold 187 tickets and the Board is in favor of offering this discount again.

3. New County Administrator:

Commissioner Kerrigan met with the Directors and noticed a recurring theme of dysfunction within the Commissioners' Office. He believes the best course of action would be to bring in a County Administrator, who would be a single point person that manages the day to day operations of the County. Commissioner Kerrigan went on to say that having this structure in place keeps continuity in government, regardless of the Commissioners.

Commissioner Christian-Bennett has two concerns - funding and the fact the Board has told Elected Official and Department Heads they cannot add staff.

Commissioner Kerrigan presented two documents he would like the Board to review and discuss during next week's meeting.

Director Roberts discussed the structure at the City of Kent and Commissioner Kerrigan agreed to talk with Kent City Manager, Dave Ruller.

Commissioner Christian-Bennett mentioned United Way would like to add a link to the County's website for the 211 Information Line and the Board agreed to add the link to the County's website.

WHEREAS,

the Board of Commissioners owns two easements granted to the Board for the purpose of constructing and maintaining unspecified water and sewer facilities between Russell Drive and a drainage channel adjacent to the former Gillie Wastewater Treatment Plant, in the City of Streetsboro, to wit: an easement from Carl Summers recorded Feb. 1, 1980 at Vol. 975, pages 654-658 of Portage County records, and an easement from Carl and Diane Summers recorded March 26, 1982 at Vol. 994, pages 194-197 of Portage County records; and

both easements are assignable without limitation; and
