**STREETSBORO BIOSOLIDS DRYER REPAIRS**

Sealed proposals will be received at the office of the Portage County Director of Internal Services, Portage County Administration Building, 449 South Meridian Street, Ravenna, Ohio, until 2:00 PM on Wednesday, April 12, 2023, at which time and place the proposals will be opened and read to the public in the Lobby of the building entrance off Chestnut Street.

Proposals will be received for the following items of work:

**STREETSBORO BIOSOLIDS DRYER REPAIRS**

The Contractor shall provide all labor, material and equipment necessary to disassemble, replace dryer parts, and reassemble the dryer as indicated on the drawings and specifications. The project is located at the Streetsboro Wastewater Treatment Plant at 9501 Jefferson Street, Streetsboro, Portage County, Ohio.

Estimated Costs of Construction:

STREETSBORO BIOSOLIDS DRYER REPAIRS: \$1,500,000.00

The Contractor shall familiarize himself with all of Section 20, including 'Information and Instructions to Bidders' and 'Special Construction Requirements' prior to bidding.

A pre-bid meeting will be held at the project site (9501 Jefferson Street, Streetsboro, Ohio 44241) on Thursday, March 23, 2023, from 10:00 AM to 12:00 PM. The intent is to give the Contractor the opportunity to become more familiar with the project and attendance is optional. **All bids must be submitted on the bid forms included in the Contract Documents and returned with the bid book in its entirety.**

The Bid Guarantee is conditioned to provide that if the Bid is accepted and awarded, the Bidder will enter into a contract with the County and will file a Performance Bond as required.

The Bidder to whom the Contract is awarded will be required to furnish a Performance Bond in the sum of 100 percent of the Contract price for the faithful performance of the Contract.

If the Bidder selects "Bid Guarantee" Option A, the Bidder may use this Bond as the Performance Bond.

Each Proposal must contain the full name of the party or parties submitting the documentation and all persons interested therein. Each Bidder must submit evidence of its experiences on projects of similar size and complexity. The bidder shall purchase the plans and a contract book to become a qualified participant before final bid submittal. All questions shall be directed to the Portage County Water Resources Department in writing to [aneff@portageco.com](mailto:aneff@portageco.com). The Owner intends and requires that the project be completed no later than four hundred eighty-six (486) calendar days after the "Notice to Proceed" is issued.

Each Proposal must be sealed and marked "STREETSBORO BIOSOLIDS DRYER REPAIRS, Project No. ST-4 (21-060)".

Domestic Steel use requirements as specified in section 153.011 of the revised code apply to this project. Copies of section 153.011 of the revised code can be obtained from any of the offices of the Ohio Department of Administrative Services.

This project is being funded by the American Rescue Plan Act (ARPA) which requires that domestic steel be preferred for the project.

The Portage County Commissioners reserve the right to waive any informality or to reject any and all bids.
