## WESTERN RESERVE WWTP SLUDGE TANK

The Contractor shall provide all labor, material, and equipment necessary to construct two precast sludge holding tanks approximately 9 feet in width, 34 feet 6 inches in length, and 10 feet 8 inches in height. Tanks are to include six (6) diffuser assemblies connected to an existing airline, a 4-inch Polyvinyl Chloride SDR-35 influent piping with appropriate valving to both tanks, an overflow line for each tank with appropriate valving to isolate each tank, an aluminum handrail at a minimum height of 3 feet 6 inches above grade, and an 18-inch square cast in place concrete ballast around the perimeter of the tanks for anti-floatation. Project located at the treatment plant, 11708 State Route 88, Garrettsville, Ohio 44231.
