

# Independent Living Services

For youth age 14-21 who are in the custody of Portage County Children Services or emancipated foster youth living in Portage County



Job & Family Services

### <u>Financial services available for</u> <u>Independent Living Youth</u>

Youth must provide vendor sheet, invoice, and/or original receipt to issue payment

- Social & recreation funds: sports, scouting, 4H, cheerleading, pool pass, homecoming attire, etc.
- Camps
- Senior Expenses: Senior pictures, cap and gown, class ring, prom attire (hair not included).

## Upon approval, Chafee funds can be used to pay all or a portion of the following support services:

- Over the counter medications
- Driver's education classes/test costs
- Furniture
- Tools/work supplies
- Uniforms/professional clothing
- Matching funds (dollar for dollar) with youth's savings for the purchase of an automobile

(Youth may be asked to research and compare costs before purchasing items)

\*NOTE: the maximum lifetime amount of matching independent living funds for purchase of an automobile is \$2,000 and contingent upon agency approval of the overall independent living agreement and service plan. Contingent on having employment and insurance.

All services are subject for approval and may require additional documentation and research. Ask your caseworker if you are unsure prior to making the purchase.

\*\*The youth are responsible in obtaining information, research costs, and provide documentation listing the cost for social and recreational funds, camps, and senior expenses.\*\*

# Additional services and funds available to emancipated youth in Portage County:

Emancipated Youth: youth in the agency's legal custody at the time they reach 18 or are between the ages of 18-21 and meet specified criteria are able to utilize additional funds. Funds may be used to pay for the following services:

- Assistance with rent
- Furniture
- Medications
- Other services may be available

\*NOTE: Once the youth ages out of foster care and custody has been terminated, they are required to call the Portage County Cares Line, (330)296-CARE, and request Emancipated Youth Services in order to take advantage of Emancipated Youth Services.

### **Incentive Overview**

14 Years old or in the 7th grade and up
For each grading period that youth receive the
following GPA, report card must be submitted to
social worker for verification.

\*\*It is the youths responsibility to submit the required documents to receive incentives\*\*

GPA	CHECK AMOUNT
2.0-2.49	\$25
2.5-2.99	\$50
3.0-3.49	\$75
3.5+	\$100

Employment, Education, and Savings
Provide the most recent pay stub to your social
worker to verify length of employment and receive
one of the following:

#### **Employment Retention**

3 Months = \$25

6 Months = \$50

9 Months = \$75

12 Months = \$100

#### Graduation, GED, or Trade

\$500 upon verification of graduation, GED, or trade certificate

#### **Savings Match**

Up to \$500 savings match for the minimum dollar amount kept in the Independent Living youth's savings account for an entire six month period. Account must be in the Independent Living youth's name and bank statements must be provided for verification. Matching amount starts over every six months and will not exceed \$500 for each six month period.

\*\*All money received from the incentives must be put into a savings account and cannot be spent without a social workers approval\*\*
