Instructions Adult Adoptions

Requirements

Pursuant to Ohio Revised Code 3107.02: An adult may be adopted if he/she:

- o If the adult is totally or permanently disabled;
- o If the adult is determined to be a person with an intellectual disability;
- o If the adult had established a child-foster caregiver, kinship caregiver, or child-stepparent relationship with the petitioners as a minor, and the adult consents to the adoption;
- o If the adult was, at the time of the adult's eighteenth birthday, in the permanent custody of or in a planned permanent living arrangement with a public children services agency or a private child placing agency, and the adult consents to the adoption:
- If the adult is the child of the spouse of the petitioner, and the adult consents to the adoption.

See Ohio Revised Code 3107.04 to determine if the adoption may be filed in Portage County.

CAUTION: Per Ohio Revised Code 3107.15, if adoptee intends to keep one natural parent on the birth certificate and add Petitioner, then the Petitioner **must** currently be married to that natural parent. Otherwise, Petitioner will replace all natural parents on the birth certificate.

The Process

The documents listed below must be prepared by the applicant or his/her attorney, and brought into the court for filing, along with the filing fee. Once the documents have been approved for filing by the court, a hearing will be set. **Per ORC 3107.14**, **the Adoptee and the Petitioner must be present at the hearing.**

Note: On all paperwork you must use <u>full</u> names for everyone (first name, full middle name, and last name)
All paperwork must be typed. We will not accept handwritten documents.
All filings must be single-sided. We will not accept double-sided originals.
Please do not staple original paperwork. We cannot accept filings with staples.

If this Ohio form is submitted with the initial filing, our Court will assume that the Petiti determined it to be acceptable, and we will proceed accordingly. 							
	Final Order of Adoption (Form 19.1) On the line where it says "on consideration thereof the Court finds (R.C. 3107.02(B))", one of the following must be typed in: o "has established a child-foster caregiver relationship with the Petitioner as a minor" o "has established a kinship caregiver relationship with the Petitioner as a minor"						

"has established a child-stepparent relationship with the Petitioner as a minor"
