Instructions Private Agency Adoptions

Requirements

The parties use the services of a licensed adoption agency. Probate Court involvement will be at the final stages. It is the agency who will approve the adopting parents, their home's suitability, the selection and placement of the child in their home, and advise when to finalize the adoption, subject to the Probate Court's approval. The agencies have a trained, professional staff and use legal counsel to ensure that the adoption is legally and efficiently handled. See Ohio Revised Code 3107.04 to determine if the adoption may be filed in Portage County.

Per R.C.§ 3107.14, the Adoptee and the Petitioner must be present at the hearing.

Note: On all paperwork you must use <u>full</u> names for everyone (first name, full middle name, and last name)

All paperwork must be typed. We will not accept handwritten documents. All filings must be single-sided.

We will not accept double-sided originals. Please do not staple original paperwork. We cannot accept filings with staples.
