## Emergency Protective Services Proceeding Instructions

## Requirements

Portage County Department of Job and Family Services Adult Protective Services Department has identified an incapacitated Adult who has been reported to have been subjected to abuse, neglect, or exploitation, and an emergency exists that necessitates immediate action by the Court. After investigation, the Department, through its counsel, the Portage County Prosecutor' Office, has determined that this person needs court ordered protective services and there is no other person who has the authority to consent to protective services on the Adult's behalf.

Note: All paperwork must be typed. We will not accept handwritten documents.

All filings must be single-sided. We will not accept double-sided originals.

Please do not staple original paperwork. We cannot accept filings with staples.
