#### **DEPARTMENT OF BUDGET & FINANCE**

#### Discussion:

Geotab

Director Harris reviewed the report of authorized users for Geotab and Todd Bragg and Dave Lair were listed, JoAnn Townend, Gerry Lower and himself. Todd and Dave have been removed as they are no longer with the County. The County has been paying for the services since 2019 and it was installed at the beginning of 2020.

#### Pros:

- Vehicle tracking, speed, seatbelt use, idling, harsh cornering, and location.
- The trackers can pair with the fuel cards to ensure fuel is being pumped into the correct vehicle. It also ensures the number of gallons that are pumped fits in the specifications of the vehicle's fuel tank.
- Geotab provides Enterprise with the odometer reading automatically for oil changes or fuel cards. This service is standard for all vehicles that participate with Enterprise.
- It can also provide information for vehicles we don't typically use, so if we wanted to downsize or transfer a vehicle to another department or combine several departments to one vehicle, we can do that.

Commissioner Christian-Bennett noted we are involved with Geotab because we were used to the Motor Pool following up with everything and then there was no one to control the information, so it was put under Director Bragg to monitor and then Dave Lair.

Administrator Crombie noted the Geotab is the tracking device, but if an employee used the gas cards where they would have to enter the odometer reading, is there any way that Enterprise could track the vehicle from a safety standpoint (i.e., oil changes, tire rotations, etc.) in lieu of the County paying \$18.00 per vehicle? We could have different PIN numbers for fuel cards as needed because some of our employees share vehicles, in particular the Sheriff's Office. So, we could have one fuel card per vehicle and then whatever Deputy steps in and takes the vehicle, would enter their PIN and the odometer reading. Director Harris stated that practice is currently being done.

Commissioner Christian-Bennett asked if Enterprise is tracking the oil changes or Geotab and Administrator Crombie explained Geotab is used when you want to know where your employees are and what exactly is going on with the vehicle, but the maintenance goes through the card to Enterprise.

Director Harris explained everything can intermingle, but no one is receiving notification when necessary – the reports are out there, you just have to log in to see them.

The County has 84 trackers and 1 vehicle was sold at auction with a tracker still on it and seven vehicles were for the Sheriff's Office that sold at auction. There are 128 County-owned vehicles.

Commissioner Badalamenti noted if the Sheriff's Office is unable to get ahold of a Deputy, the vehicle can be tracked through Geotab and that's important, but the gas card seems reasonable for everyone else. Director Harris pointed out it doesn't have to be done on every

vehicle; it can be done based on the Department. Commissioner Badalamenti asked that the Sheriff is contacted on how he would like to move forward with his vehicles.

Everyone is listed with the exception of the Prosecutor's Office, Municipal Court, Water Resources and Soil and Water. There are 2 Solid Waste vehicles that have tracking devices on them.

Administrator Crombie explained we need to do a better job at monitoring the vehicles and educating Department.

Director Harris pointed out that Geotab is canceled at this point because they are switching from Sprint to Verizon.

Commissioner Badalamenti suggests Director Harris touch base with departments to ascertain whether they want to continue to track their vehicles.

Commissioner Christian-Bennett is concerned that we aren't receiving the reports and the trackers weren't even working, but Director Harris explained you need to log in to gain access to the data.

Director Harris also noted we are able to tell if a tracker was removed and put back on because we would receive an alert.

Administrator Crombie asked if Enterprise could set up an automatic alert for an oil change attached to fuel card usage? Commissioner Christian-Bennett would like to know what products are available and exactly how they work on our end and Director Harris will investigate and report back.

# Discussions:

1. January/February 2022 JFS Data Report

Under childcare, we saw a reduction in children in need of subsidized childcare from January to February. We're not really sure why there's a decrease, it might be because February is a shorter month, but we're going to watch that number as we move forward.

On page two, there were about 400 less calls in Customer Service Center, which is a good thing.

On page three, the state's unemployment rates came out and the March rates for Ohio are 4.1%. In the United States, unemployment is 3.6%. We didn't get our March rates reported yet, but we're really in line with where the state is at with unemployment.

Commissioner Christian-Bennett asked about the total number of business services provided because it dropped drastically from 538 in January 315 in February and Director Jeffries replied that's based on employers' outreach or that they're getting gainful employees and the needs aren't as great.

Under the total number of hiring events, the word 'schools' is listed, but it should say 3 hiring events in the month of February.

Page four, the SNAP ENT participation rate in January there's a Federal waiver that we were not required to work with individuals on food assistance benefits, because of pandemic. So that waiver has since been lifted and we're working to transition those folks into our new connections program. So, we're going to really assess what their needs are and move forward.

Children's Services, I'm going to highlight Adult Protective cases, too. In February, we assigned 13 cases to our social worker on the Adult Protective side and as far as children and custody at the end of February, we had 203 kiddos in care, as of this Monday, 193.

# 2. Public Assistance/Ohio Means JOBS

a. Benefit Bridge Pilot

The Ohio Department of Job and Family Services has invited Portage, Erie, Franklin, Montgomery and Galya County to participate in Cohort two, of what's called the Benefit Bridge Pilot Program and we have a call with the State and the other counties tomorrow. If we move forward as a pilot program, we would be assisting individuals who move towards gainful employment, but oftentimes when individuals get employment, their benefits change, so their food stamps might decrease, their insurance could go away, if they're in subsidized housing their rent may go up, so it's not that we don't want to support self-sufficiency, but we recognize that the transition is not as seamless as we'd like it to be.

If we move forward with this, they're going to offer these counties extra TANF and GRF funding from the State and they want the Benefit Bridge team and pilots to work with peer mentors, case managers, finance and budgeting, and career coaching, and then have a therapist component to it, because some people are dealing with mental health issues, as well. So, this is the team they want counties to build, and I'm believing they're going to

subsidize us if we move forward. So, I'll update you next meeting, but Director Jeffries would like Portage County to be part of the pilot program.

Commissioner Badalamenti asked if anyone has tried to allow a 60-day minimum before Job and Family Services subsidy is removed once a person obtains employment and Director Jeffries noted it's all federal and state-based and I think it's exciting because then they can advocate for a change in policy and if state policy changes, they may be able to influence federal, then we wouldn't have to be mandated to take that action right away. I think it's the right thing to do.

Job and Family Services has been working on a poverty simulation and we're going to present it to you, but we want to have this experience for our private sector employers and community partners to understand what a month and a life of somebody on assistance is like and I think we can interface this new piece into the experience. So, I wanted to present that to you here in the next month or so. So, I think it's a good tie-in if we can move forward.

- 3. Child and Adult Protective Services
  - a. Temporary Visitation Accommodations and RFP follow up

The County graciously has allowed us to use the Portage County Annex Building through July to hold temporary visitation appointments.

The same scenario also applies to Resolution No. 4. Commissioner Christian-Bennett will reach out to Mr. Sernik.

# **HUMAN RESOURCES**

#### Discussion:

1. Retire/Rehires – DRAFT Sick Leave Incentive Program

Last week, the Board discussed allowing retired/rehired employees to participate in the sick leave incentive program. There were 41 employees that retired/rehired and out of the 41, 27 are General Fund employees. The worst-case scenario if all 27 were eligible for the program and took the maximum number of sick leave (80 hours), paid out at 60% over the hourly wage, we're looking at just under \$38,000. The County has a little over 1,000 employees.

Commissioner Christian-Bennett believes it's a nice perk to employees and it doesn't impact a lot of people and Commissioner Badalamenti agreed. Commissioner Christian-Bennett pointed out Commissioner Kline was in favor of the new policy, as well.

Director Kovick will prepare a resolution for Board consideration next week.
