ENGINEER'S OFFICE

Present: Engineer Larry Jenkins Jr. & Storm Water Educator Lynn Vogel

Discussion:

1. Amendment to Storm Water Grant

Engineer Larry Jenkins introduced Lynn Vogel as the Storm Water Educator and stated that they would like to review a Storm Water Amendment. There was an educational grant that was implemented with a resolution as part of the stormwater utility in 2022. A new teacher has taken over running the program at Ravenna High School and Lynn Vogel has taken a lot of time working with the school to modify the grant agreements to benefit education. The modifications that are taking place do not change the original grant agreement cost of \$24,000. Mr. Jenkins stated that Lynn Vogel did a phenomenal job on the project.

Lynn Vogel stated that the previous educator that she worked with at Ravenna High School had to leave her position for personal reasons. She was very committed to wetland education and was interested in having floating decks or supported platforms installed in the wetland for her class to utilize as well as trails throughout. These decks were included in the original scope of work. The new educator is still committed to wetland education but would like to take away the supported platforms. The grant still includes all the same materials such as boots and equipment to collect samples for field identification. But instead of the floating decks they now are proposing that they construct a nature trail around the school perimeter. It would be more open to other subject areas and the community. Walking trails have been completed at other schools such as Garfield and Waterloo. Students there created stormwater messaging signs which is also the intention of Ravenna.

Ms. Vogel showed examples to the Commissioners of what the signs would look like and explained that they are going to enhance an existing kiosk by the tennis courts.

Ms. Vogel showed an example of the kiosk at Waterloo School. It has messaging inside the kiosk which explains how permeable pavers work and why impervious surfaces are a problem. Ms. Vogel presented pictures of the Waterloo Trail as an example and explained how the trail at Ravenna will be similar in the addition of bird boxes, nest boxes, and feeding plates for wildlife. A quarter (1/4) acre pollinator habitat will also be added right along the trail.

Commissioner Badalamenti asked how much area was available around Ravenna High School. Ms. Vogel said that the trail will be about a mile along the outskirts of the property.

Commissioner Christian-Bennett added that it is all wetlands. Ms. Vogel responded that they are addressing that concern with the addition of three (3) wood bridges to pass through the wet areas. Six (6) benches along the trail will also be added.

Ms. Vogel presented examples of the signs that were created by Art Students at Garfield High School when the Nature Trail was created there. The Ravenna Trail will depict a strong storm water message at the beginning with use of the Ravenna Mascot, the Raven.

Mr. Jenkins added that this is a cooperative type of grant where they are collaborating with the City of Ravenna who also have a financial investment in the project of around \$5,000.

Ravenna High School has also contributed and started performing work. He states that it is a good proposal and that Ms. Vogel, and the school have done great at working through the challenges. Mr. Jenkins appreciates the partnership.

Commissioner Badalamenti stated that the biggest difference is the elimination of the floating decks which he feels could have caused safety concerns.

Ms. Vogel agrees and states that she prefers the updated plan, but the support she provides is to the educator and their needs. She thinks that the updated plan will be utilized more by other educators from a range of departments as well as community members.

The resolution will be coming forward with Internal Services. The Commissioners thanked Ms. Vogel and Mr. Jenkins for their time and asked if they could be informed when the Trail Project was coming close to completion.

PUBLIC COMMENT

Mr. Frank Hairston along with Gene Brown, Jason Mack and Rick Maxwell turned in a Public Comment Form. The topic regards changing the name of Portage Street to Deseree Liddell Boulevard.

Mr. Hairston addressed the Commissioners with Mr. Gene Brown by saying that they are representing the Skeel's Community. He states that by ORC 554.104 a Board of County Commissioners may change the name of a Township Road on the Board's own motion. He is asking for the name of Portage Street altered to Deseree Liddell Boulevard in honor of Mrs. Liddell.

Commissioner Badalamenti asked Mr. Hairston to explain who Mrs. Liddell is. Mrs. Liddell is a long-time Portage County resident who has lived in the Skeel's Community. She helped raise Mr. Hairston and Mr. Brown along with many other people. Mrs. Liddell has done great things not only in the Skeels Community and the Black Community but all over Portage County. She has run the Skeels Community Center and sat on many Boards throughout the County over the years. She is an author. She has great love for the community, the people, and Portage County. She always has positive things to say about Portage County as this is where she raised her family after she came here from Alabama. Mr. Hairston asks that they change the name of the street to honor her.

Commissioner Badalamenti clarified that the name of the street would change to be Deseree Liddell Boulevard.

Mr. Gene Brown added that Mrs. Liddell started a tutoring program for young kids in the early 60's. She ended up being affiliated with Kent State. Mr. Brown's first introduction to Mrs. Liddell was being a part of that program.

Commissioner Badalamenti asked how old Mr. Brown was when he participated in the tutoring program. Mr. Brown states that he was in the seventh grade. The interesting part was Mrs. Liddell was able to get the Kent State Students to come to her house to tutor.

Mr. Hairston stated that was before there was a center. He added that Mrs. Liddell was also instrumental in getting water and sewer in the Skeels and King Kennedy Community Centers. She also had an influence in the implementation of paved roads in the area.

Commissioner Christian-Bennett asked how many residents would be impacted by the name change? Mr. Hairston answered that there are only two (2) structures on Portage Street. One is a church, and the other is a metropolitan house. He has spoken to all who would be impacted, and everyone is on board with the change. Mr. Hairston stated that they decided to change "street" to "boulevard" because there are not many boulevards, and they are hoping that the name would give appeal and bring organizations to build more homes in the McElrath and Skeels Communities.

A Community Group has been created and they are planning on implementing some positive changes. The group is currently working with Ravenna Township Trustees on the demolition of a barn that is located behind the church.

Commissioner Tinlin stated that he started working in the County in the late 70's. He states that Mrs. Liddell was a mentor for him in the area and that she was always a genuine lady. He agrees with putting forth the motion for the street name change. Commissioner Badalamenti and Commissioner Christian-Bennett agree that it is a good idea.

Commissioner Christian-Bennett asked Mrs. Liddell's age. Mr. Hairston replied that she is 95 and still attends different events. He also acknowledged another special lady Mrs. Prisby, who is 101 years old.

Commissioner Badalamenti asked how long they have lived in the Community. Mrs. Liddell has lived in the Community for over 50 years. Mr. Hairston gave some history pertaining to how the family moved here for Mrs. Liddell's husband to work at the Ravenna Arsenal.

The neighborhood of Skeels and McElrath was created for Black workers at various places such as the Arsenal and Chrysler. Mr. Hairston continued by stating that once owned by a farmer, the area was sectioned out and auctioned off at a movie theatre in Cleveland. He concluded by stating that there is a lot of interesting history in the area.

Commissioner Christian-Bennett went through what the next steps of the process will be regarding the name change. The Prosecutor's Office will be contacted, and a Public Hearing will be held where the Ravenna Township Trustees and the public will be notified. It has been determined that there is a good cause to change the name. A resolution will be adopted, and then forwarded to the Engineers Office, the Auditor's Office, and the County Recorder to respectively note and change the record. The Commissioners' Clerk will reach out to the Prosecutor's Office to proceed with the resolution.

The Commissioners thanked Mr. Hairston and Mr. Brown for pursuing the change and stated that it was an excellent cause.

Mr. Hairston and Mr. Brown thanked the Commissioners for their time, and they stated that they would notify the Board when a Ribbon Cutting Ceremony will take place.
