DEPARTMENT OF BUDGET AND FINANCIAL MANAGEMENT

Present: Director Todd Bragg

Director Bragg presented two budget resolutions for Board consideration and noted the following:

General Fund Resolution:

- The Veterans Service had a healthcare change that needed an adjustment.
- The Common Pleas Court had a vacation payout.

Non-General Fund Resolution:

- Job and Family Services was \$65,000 under budget in their salary lines and the funding was moved from Contractual Services into Salaries to cover the expense.
- The remaining items listed on the Non-General Fund Resolution are decreases, pulling down certifications so the Auditor's Office doesn't have any appropriations over budget.
- The County Engineer entries are mostly decreases and when the reimbursements aren't received on time, certification is pulled down to match the amount received. This doesn't mean the work wasn't done, but that the payment was not received in 2019. Next year, the budget for the County Engineer's Office will be reset and the projects will be finished.

Journal Voucher Resolution:

Director Townend pays the invoice for Office 365 and then does a 'charge back' to each department. The charge back wasn't entered before the Commissioners' last meeting as Director Townend was working with Information Technology Services to get the breakout of users and that was the reason for the delay.
