F. Resolution #22-04 The Portage County Board of Health Acceptance to allow Joseph Diorio to sign the Agreement with Kent State University to Provide Epidemiological Assistant Services for COVID-19 Pending Contract Completion.

Mr. Diorio stated that this to utilize grant funding to hire five Epidemiology Assistants which are currently KSU students that had been trained for Contact Tracing and have them listed under one contract to be funded, which is currently totaling \$83,200. The grant ends June 30, 2022. These epidemiology assistants' services would begin once the contract has been completed and agreed upon with dates and a contract total. Mr. Diorio stated that PCHD currently has four epidemiology assistants who are currently working 40 hours per week. In having the extra epidemiology assistants, this would aid in balancing their time. This would also give PCHD a total of nine epidemiology assistants to assist PCHD with the COVID-19 pandemic.

S. **Resolution #22-17** Declaring a Public Nuisance, Ordering Abatement of that Nuisance Located at 4737 Mogadore Road, Brimfield Township and Approving the Civil Prosecution for Violation(s) of Ohio Revised Code (ORC) Chapter 3718 and Ohio Administrative Code (OAC) Chapter 3701-29 Sewage Treatment Systems.

Mr. Rechichar explained that this is 1 household of 57 households inspected in this development, that is illicitly discharging sewage. This property continues to operate on an old aeration system and does not have a motor. The homeowner was given numerous notices and PCHD contacted the Portage Water Resource department, per Ms. Speck, this homeowner has not complied to repair the sewer system for this property. The EPA was notified and ordered that this sewer system be ran and brought to compliancy, however, the homeowner has not complied. Board member, Dr. Minott inquired on assistance for the homeowner through the WPCLF grant. Mr. Sarfo informed the board that each time a complaint was filed, resources on how to apply for the WPCLF grant were provided to assist the homeowner. Mr. Diorio stated that the homeowner can still apply for the WPCLF grant to assist in repair of the sewer system, however, PCHD would like the board to move to approve in declaring this property as a public nuisance and rectify this issue.
