FOOD SAFETY TRAINING



LEVEL ONE FOOD SAFTEY TRAINING:

OAC 3701-21-25(I); 901:3-4-16(C)

Level One Certification in Food Protection is mandated for the person in charge of each shift at a risk level I, II, III, and IV food service operation (FSO) or retail food establishment (RFE) in the following situations:

- When a new FSO or RFE is licensed after March 1, 2010 (unless the individual has successfully completed Level Two Certification).
- When an FSO or RFE has been implicated in a foodborne disease outbreak.
- When the licensor has documented failure to maintain sanitary conditions [per section 3717.29 of the Revised Code (for an RFE) or per section 3717.49 of the Revised Code (for an FSO)].
