RE: REVISING THE TATTOO AND BODY PIERCING SERVICES (BODY ART) FEES TO COMPLY WITH OHIO REVISED CODE (ORC) CHAPTER 3730 AND OHIO ADMINISTRATIVE CODE (OAC) CHAPTER 3701-9. FEES TO BE EFFECTIVE NOVEMBER 1, 2022.

WHEREAS, the Board of Health of the Portage County Combined General Health District is desirous of preventing disease and maintaining the integrity of the health, safety and morals of the citizens of the Portage County Combined General Health District;

WHEREAS, the Board of Health of the Portage County Combined General Health District is desirous of performing its duties in regard to administering, licensing, and inspecting the Tattoo and Body Piercing Services (Body Art) Program as required;

WHEREAS, Ohio Administrative Code (OAC) 3701-9-03 states each board of health shall utilize the cost methodology specified in rule 3701-36-14 of the Administrative Code to calculate fees for providing services specified in section 3730.03 of the Revised Code. The calculated fees shall not exceed the cost of issuing approvals and inspecting body art establishments;

WHEREAS, Ohio Revised Code (ORC) 3730.03 states an applicant seeking to operate a business that offers tattooing and body piercing (body art) services shall apply to the board of health and shall include the fee established under section ORC 3709.09 of the Revised Code with the application;

WHEREAS, ORC 3709.09 and OAC 3701-36-14 allows board of health to establish uniform system of fees for licenses to pay the costs of any services provided by the board and shall include the cost of licensing and all inspections;

WHEREAS, OAC 3701-9-02 states that every person who intends to renew an approval to operate or maintain a body art establishment shall apply to the board of health on or after November first of each year. Applications received or postmarked after December thirty-first shall be assessed a penalty as authorized by section 3709.09 of the Revised Code;

WHEREAS, due to the results of required cost methodologies it is necessary to revise the associated fees to cover the costs to institute and administer the Tattoo and Body Piercing Services (Body Art) Program, and






