


Market Environment

- The Federal Open Market Committee (FOMC) reaffirmed its current 0% to .25% target range for the federal funds rate. Members have opposing views as to how quickly rate increases should begin.
- The European Central Bank continued purchasing asset-back securities in its attempt to provide stability to the struggling European economies. Overnight rates remain at 0% to .05%.
- Oil prices have hit 5 year lows sinking below \$50 per barrel from their highs of over \$105 this summer.


Gross Domestic Product (GDP)




Inflation






Where Are We Investing?

- •We continue to believe that the Fed will not raise interest rates until late 2015 to early 2016.
- •Short Maturities: For maturities inside of 2 years, our view is that the greatest value is in bank products.
- •Long Maturities: We continue to believe there is value in callable U.S. agency securities in the 3-5 year range, and we are recommending clients target a 30-40% allocation of their core investment portfolio to this maturity range.




